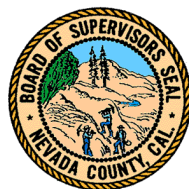

Public Comment:

ACTION TAKEN: The following members provided comment: Mr. Joseph Winkler, District IV resident; Ms. Molly Fisk, District IV resident and the first Poet Laureate of Nevada County; Mr. Wade Laughter, District I resident; and Mr. Richard Benuzzi, District III resident.

Public Health Director: Jill Blake

1. [SR 20-1484](#) Acceptance of the report from the Nevada County Public Health Department regarding the 2019 Novel Coronavirus (COVID-19). (Dr. Kenneth Cutler, Public Health Officer)
Accepted.

ACTION TAKEN: Ms. Jill Blake, Public Health Director, and Dr. Kenneth Cutler, Public Health Officer, provided a PowerPoint presentation regarding the 2019 Novel Coronavirus (COVID-19), and the potential for the virus to become a pandemic. Dr. Cutler outlined the differences between the flu and COVID-19, and reviewed the known statistics regarding both illnesses. Currently, there are no confirmed cases in Nevada County, although there are cases identified in neighboring counties. Dr. Cutler reported that there is no vaccine available for the virus and no recommended antiviral treatment. He reviewed the transmission and fatality rates and its impact on vulnerable populations, which includes individuals over 65 years old and individuals with underlying health conditions.

Ms. Blake reviewed the non-pharmaceutical interventions that members of the public can take, including: hand washing, social distancing, and planning and preparing for issues that may affect the entire community, such as public transportation and school closures. She reviewed the public health outreach to the Nevada County community and the guidance document Public Health has created for local employers and businesses to use. She encouraged businesses to develop their own plan for business closure and disruptions in staffing. Dr. Cutler reiterated the critical importance of hand washing to help slow down the spread of the virus, and stressed the importance of individuals with the illness staying home while they are sick. He stressed that frequent disinfection of surfaces is a key way to make a difference in the spread of the disease. Dr. Cutler explained how to interrupt the spread of the disease, including: quarantine; isolation; testing; and contact investigations.

Ms. Blake reported on the readiness of our emergency health care system and Nevada County's emergency preparedness and response and spoke about the Emergency Preparedness Interagency Coalition (EPIC), which includes hospitals, clinics, first responders, skilled nursing homes, and other health care providers in our community.

Dr. Cutler explained that not everyone who wants to be tested will be able to. He anticipates that up to 40 individuals per day can be tested locally, which includes neighboring jurisdictions. It is expected that 2-1/2% of Californians will experience flu-like symptoms. He is hoping that the ability to increase testing will go up soon, but asked for patience. As for local capacity, recognizing who has the virus and who does not is difficult. Individuals with mild symptoms have the ability to transmit the disease; he stressed that people should stay home if they are experiencing symptoms, even if they seem mild. Dr. Cutler reported that this is a rapidly evolving situation; the Public Health Department will be learning more as the event continues. He stressed the need for the community to be prepared.

Board questioning and discussion ensued.

Supervisor Anderson wanted the public to be aware that the MyNevadaCounty home page continues to provide up to date Corona Virus information. Ms. Blake also suggested the public can call 211 for information.

Chair Hall provided an opportunity for public comment, and the following members of the public spoke: Mr. Brian Snyder, FREED Center for Independent Living Disability Community Advocate; and Ms. Robin Milam, District I resident, Nevada City Rotary member and Bear River Land Trust representative.
