ACTION TAKEN: Ms. Louise Zabriskie, District V resident, and President of Friends of the Truckee Library requested the Board reschedule this item after County staff has received input from the Truckee Community and has considered the appropriateness and scope of the currently proposed contract. She felt there were structural changes that conflict with new library plans, and that the proposed contract is not a good use of Measure A funds.

Mr. Justin Drinkwater, Facilities Program Manager, spoke in support of pulling the agenda item to allow time to gain further input.

Ms. Yolande Wilburn, County Librarian, clarified that the Resolution is not to allocate \$500,000 to remodel the Truckee Library, it is for a \$45,000 contract with architects, which would allow open discussion with the members of the Truckee community to gather their thoughts and desires for their library. All County libraries require repair and refurbishing; they are working with Facilities to assess and improve the infrastructure and update the Library's facility plan. In 2015 the estimated costs for a new Library in Truckee would be over \$14 million; today's agenda item contract will allow the County to provide an expanded more desirable and usable space until Truckee is able to build a new facility.

Board questioning and discussion ensued.

Chairman Anderson provided an opportunity for public comment. The following members of the public provided comments: Ms. Kathleen Eagan, District V resident; and Ms. Cathy Eccles, District V resident.

12. [SR 19-0185](#) Presentation provided by Ms. Marina Bernheimer, Community Support Network - Child Abuse Prevention Council of Western Nevada County, "Adverse Childhood Experiences - What are ACES and how is Nevada County Working to Mitigate the Harm?"

Resolution proclaiming April 2019 as Child Abuse and Neglect Prevention Month in Nevada County.

ACTION TAKEN: Mr. Tex Ritter, Director of Social Services, introduced Ms. Marina Bernheimer, Community Support Network - Child Abuse Prevention Council of Western Nevada County, noting that the month of April is Child Abuse and Neglect Prevention Month in Nevada County.

Ms. Bernheimer provided a PowerPoint presentation entitled "Adverse Childhood Experiences - What are ACES and how is Nevada County Working to Mitigate the Harm?" She reported that adverse childhood experiences can include physical or emotional abuse or neglect; and all types of household dysfunction. Impacts caused by these experiences can effect adulthood behavior, increasing the likelihood of depression and anxiety, cancer, and heart disease. The good news reveals that the community can work together to prevent high ACES scores and to build resilience through trauma-informed services; prevention and early intervention; and evidence-based interventions.

Board questioning and discussion ensued.

Chairman Anderson read the Resolution into the record and the Board members presented it to Ms. Bernheimer.

ACTION TAKEN: Ms. Eliza Tudor introduced Mr. Chris Olander, the Nevada County Poet Laureate. Mr. Olander spoke to his love of Nevada County rivers and rivers as a metaphor for life. He recited one of his poems, written about rivers, into the record.

Ms. Yolande Wilburn, County Librarian, was looking forward to partnering with Nevada County Arts Council to promote poetry throughout the County.

Board discussion ensued.

Chairman Anderson provided an opportunity for public comment:

Ms. Linda Chaplin, District I resident, provided comments.

There being no further public comment, Chairman Anderson closed the public comment opportunity.

The Board welcomed Mr. Olander and congratulated him on his appointment to Nevada County Poet Laureate.

Agricultural Commissioner: Chris de Nijs

14. [SR 19-0272](#) (Introduce/Waive Further Reading/Adopt) An Urgency Interim Ordinance of the County of Nevada imposing a temporary moratorium on the cultivation of Industrial Hemp within the unincorporated areas of the County of Nevada. (4/5 affirmative vote required)

Adopted.

Enactment No: ORD-2464

ACTION TAKEN: Following a short break, Chairman Anderson called the meeting back into order. Mr. Chris de Nijs, Agricultural Commissioner, reviewed the staff report and provided a PowerPoint presentation regarding the proposed Urgency Interim Ordinance establishing a moratorium on cultivation of Industrial Hemp. It is difficult to tell the difference in the field between Hemp and Cannabis plants, Industrial Hemp requires a laboratory test to confirm the THC levels. As of January 1, 2017, Industrial Hemp cultivation was approved, and legislation regarding cultivation was refined in 2018. Procedures to register cultivators of Industrial Hemp continue to be reviewed by the California Department of Food and Agriculture (CDFA).

Mr. de Nijs reported on the County's concerns including: ability to determine land use policies; lack of a fully set-up State program; compatibility issues between Industrial Hemp and Cannabis; the difficulty distinguishing Cannabis from Hemp; and possible loop holes in the CDFA regulations and State law.

He stressed that this is not a request for a permanent ban. Staff is requesting a 45-day pause to provide time for research and outreach. Staff will return to the Board with recommendations. He requested the Board adopt the Urgency Ordinance.

Board discussion and questioning ensued.

Chairman Anderson provided an opportunity for public comment, and the following members of the public provided comments:

Ms. Sonja Sokolow, District II resident; Ms. Diana Gamzon, District I resident and Executive Director of Nevada County Cannabis Alliance; Ms. Alexandria Irons, District IV resident; Mr. David Cooper, District IV resident; Mr. Jon Oleson, District IV resident; and Ms. Patricia Rockwell, District IV resident.

There being no further public comment, Chairman Anderson closed the opportunity for public comment.

MOTION: Motion made by Supervisor Hoek, seconded by Supervisor Hall, to waive further reading and adopt Ordinance 2464. On a roll call vote the motion passed unanimously.

15. [SR 19-0257](#) Public hearing to consider adoption of a Resolution annexing the Retherford Road area into the Darkhorse Permanent Road Division, and proposed annual special tax for ongoing road maintenance within the annexed area, in compliance with Proposition 218. The Board of Supervisors shall consider all objections and protests, if any, to the proposed special tax and will tabulate the vote on the proposed special tax. A majority protest will exist if, upon the conclusion of the hearing, assessment ballots submitted in opposition to the proposed special tax exceed assessment ballots submitted in favor of such proposed special tax. Only one ballot shall be counted for each parcel, even if there are co-owners. In addition to the ballots in favor of or in opposition to the proposed assessment, the Board of Supervisors will also consider any other protests to the proposed assessment at the public hearing. If a simple majority protest exists, the Board of Supervisors will not annex the territory or impose the special tax. If at least two-thirds of ballots submitted approve the proposed special tax, the Board of Supervisors may adopt the Resolution imposing and levying the special tax starting in Fiscal Year 2019/20, to be enrolled on the assessment roll, and billed and collected along with County property taxes.

Resolution approving the annexation of the Retherford Road Area into the Darkhorse Permanent Road Division, authorizing the collection of special taxes for road maintenance services at the rate of \$298 per parcel per fiscal year, beginning in Fiscal Year 2019/20, and continuing indefinitely for each fiscal year thereafter. (Dist. II)

Adopted.

Enactment No: RES 19-142

ACTION TAKEN: Chairman Anderson introduced the agenda item, and Ms. Jessica Hankins, Public Works Project Manager, provided a PowerPoint presentation regarding the proposed annexation of parcels along Retherford Road into the Darkhorse Permanent Road Division (PRD). Staff requested the Board conduct the public hearing, take public comment, direct the Clerk of the Board to count the ballots, determine if a majority protest exists, and, if the ballot votes approve the annexation by 66%, approve the proposed Resolution authorizing the collection of special taxes for road maintenance services at the rate of \$298 per parcel per fiscal year, beginning in Fiscal Year 2019/20.

Chairman Anderson opened the public hearing for public comment. The following member of the public provided comments: Mr. Jim Hook, District II resident. There being no further public comment, Chairman Anderson closed the public comment period of the public hearing.

Ms. Hankins and Ms. Trisha Tillotson, Director of Public Works, responded to concerns raised during public comment.

Board questioning and discussion ensued.

Ms. Julie Patterson Hunter, Clerk of the Board, opened and counted each ballot. The results from a total of fourteen (14) received ballots were; eleven (11) yes votes and three (3) no votes.

MOTION: Motion made by Supervisor Scofield, seconded by Supervisor Miller, to adopt Resolution 19-142. On a roll call vote the motion passed unanimously.
