## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION ADOPTING A SUCCESSOR MEMORANDUM OF UNDERSTANDING (MOU) WITH THE PROBATION PEACE OFFICERS' ASSOCIATION, PROVIDING CHANGES IN COMPENSATION AND TERMS AND CONDITIONS OF EMPLOYMENT DURING THE PERIOD JULY 1, 2020 THROUGH JUNE 30, 2023

WHEREAS, employees of the County's Probation Peace Officers' Association are represented exclusively in matters of wages and benefits and other terms and conditions of employment; and

WHEREAS, representatives of the Probation Peace Officers' Association and Nevada County collaboratively negotiated a successor labor agreement; and

WHEREAS, the Board of Supervisors desires to adopt the attached Memorandum of Understanding which implements final language consistent with the agreement reached between the parties on March 27, 2020.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Nevada, the following salaries and benefits are hereby granted to the employees covered by the Probation Peace Officers' Association effective July 1, 2020, except where another effective date has been specified; and hereby are approved in the forms attached hereto, and the County Executive Officer is hereby authorized to sign the MOU.

BE IT FURTHER RESOLVED that all compensation, fringe benefits, responsibilities and restrictions applicable to members of this employee unit are contained in the attached Memorandum of Understanding which supersedes all agreements made prior to this date.
