1. You acknowledge that using this service is a privilege, not a right, and unauthorized use may result in cancellation of this privilege or, in some cases, criminal prosecution.
2. You acknowledge that Nevada County has the right, to the extent permitted by law, to monitor or record any and all data and connection activities for the purpose of quality control, usage analysis, legal investigations, or any other legal purpose.
3. You acknowledge that if any Nevada County staff becomes aware of activities violating this agreement they may, at their discretion, immediately end any and all Internet sessions, without prior notice, or initiate an investigation with appropriate authorities.
4. You also agree to the following:
 - a) Not to use the County's Internet for any purpose that violates federal, state or local laws, to transmit threatening, obscene, or harassing materials, or to cause disruption to others in any way.
 - b) Not to download; or upload materials that infringe copyright laws of the United States or other countries.
 - c) To respect the rights, privacy and sensitivities of others; and refrain from reading the screens of others, attempting to attack or hack other systems, or attempt to intercept, collect or store data about third parties without their knowledge or consent.
 - d) Not to use this service in any manner that may interfere, damage or disrupt Nevada County's or other's property, computing system, network, software or data.
 - e) Not to send unsolicited messages, including without limitation, promotions or advertisements for products or services, "pyramid schemes," "spam," "chain mail" or "junk mail."
 - f) Not to introduce computer viruses or destructive programs into this or any other computing system(s) California Penal code; Sec.502 et. seq.).
5. You acknowledge that printing is not available through this service, except as separately advertised.

7. You acknowledge that Nevada County has no obligation to ensure that this system will work with your system. Service is only available at designated locations; actual service coverage, speeds and quality may vary. Service is subject to unavailability, including emergencies, third party service failures, transmission, equipment or network problems or limitations, interference, lack of signal strength, and maintenance and repair, and may be interrupted, refused, limited or curtailed at any time.
