

**NCS D No. 1 Visitor Release Agreement**  
**Lake Wildwood Wastewater Treatment Plant**

In consideration of my (and/or my minor child) being permitted by the Nevada County Sanitation District (the "District") to enter the premises of the Lake Wildwood Wastewater Treatment Plant located at 12622 Pleasant Valley Road (the "Wastewater Treatment Plant") for the limited purpose of a guided tour, I agree as follows:

1. I agree to comply with all applicable rules. I will listen carefully to all information and instructions provided by authorized District representatives and I will promptly comply with all instructions. I will not engage in any activity inconsistent with the purpose of my visit.
2. I will not use tobacco products while on the Wastewater Treatment Plant property, and I will not bring or possess any weapons of any kind inside the facility or the surrounding area.
3. I will not take photographs or make drawings or representations of the Wastewater Treatment Plant or anything located inside the Wastewater Treatment Plant or on its premises.
4. With the exception of general informational brochures provided by the District as part of the tour, I will not remove from the Wastewater Treatment Plant any documents or property of any kind belonging to the District or any other party, unless explicitly authorized in writing by the District to do so. I will assume unless otherwise instructed by an authorized District representative that any information, whether written or observed, that I obtain while visiting the Wastewater Treatment Plant is confidential and proprietary in nature, and I will not disclose such information to any other person.
5. I will not touch or operate any equipment within the Wastewater Treatment Plant.
6. I understand that the Wastewater Treatment Plant is an active industrial facility that may use hazardous materials and/or chemicals known to the State of California to cause cancer, birth defects, or other reproductive harm.
7. In consideration of being allowed to visit the Wastewater Treatment Plant, I hereby voluntarily assume full responsibility for any and all risk of personal injury or death or property damage that may be suffered by me or my child during this visit to the Wastewater Treatment Plant, including injury, death or damage caused or alleged to arise from or be connected with the alleged negligence of the District. I voluntarily, on behalf of myself, my heirs, assigns and personal representatives, release, indemnify and hold harmless the District, including its officers, employees, agents, representatives, consultants, volunteers, and independent contractors, from any and all liability and costs, including reasonable attorney's fees, and waive the right to bring any claim or legal action whatsoever arising from the participants' visit to the Wastewater Treatment Plant, except with respect to personal injury or damages resulting from the District's sole and active gross negligence or willful misconduct.

8. I hereby irrevocably authorize the District, or anyone authorized and/or designated by the District, to use or reproduce any and all photography and video which have been taken while on my tour of the Wastewater Treatment Plant by the District or authorized agent(s) for any purpose by the District without compensation or further notice to me.
9. If any part of this release agreement is found to be unenforceable or invalid, that portion shall be severed, and the remainder will remain in full force and effect.

**I HAVE CAREFULLY READ AND FULLY UNDERSTAND THE WORDS AND LANGUAGE IN THIS AGREEMENT. I HAVE BEEN ADVISED OF THE POTENTIAL DANGERS THAT I MAY ENCOUNTER WHEN I VISIT THE WASTEWATER TREATMENT PLANT. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY, ASSUMPTION OF RISK AND A COVENANT BETWEEN MYSELF AND THE NEVADA COUNTY SANITATION DISTRICT, AND I SIGN IT OF MY OWN FREE WILL.**
