

Nevada County's Public Meeting Protocol in Response to Coronavirus COVID-19

California Governor Gavin Newsom issued Executive [Order N-25-20](#) on March 12, 2020, relating to the convening of public meetings in response to the COVID-19 pandemic. **The County of Nevada hereby provides notice that it will continue to convene its regularly scheduled public meetings of the Board of Supervisors until further notice.** Pursuant to the Executive Order, the Nevada County Board Supervisors will attend meetings remotely and will participate in the meeting to the same extent as if they were present. In Person Participation: Pursuant to the Governor Newsom's [Order N 29-20](#), comment in person during Board meetings is hereby suspended until further notice. To follow social distancing guidelines as outlined by the Nevada County Public Health Department, the Board Chambers will remain closed to the public.

Remote Viewing: Members of the public who wish to watch the meeting but not attend in person are encouraged to view it live online or on television. All the Board of Supervisors meetings are broadcast live on Nevada County Television (NCTV) Channel 17 in Western County, on Truckee-Tahoe Community TV (TTCTV) Channel 18 in Eastern County, and online at <https://nevco.legistar.com/Calendar.aspx>.

Written Comment: Members of the public may submit written comments on any matter within the Board's subject matter jurisdiction, regardless of whether the matter is on the agenda for Board consideration or action. Comments will be entered into the administrative record of the meeting. For comments on items appearing on the agenda: If you are watching the live stream of the Board meeting and wish to comment on a specific agenda item as it is being heard, please submit your comment through our eComment system at https://nevco.granicus.com/ViewPublisher.php?view_id=3.

Every effort will be made to read your comment into the record, but some comments may not be read due to time limitations. Comments received after an agenda item is heard will not be read but will become part of the record after the end of the meeting.

For comments on items not appearing on the agenda: For written comments not on the agenda but within the Board's subject matter jurisdiction, you may submit written comments by email, U.S. Mail, or through our eComment system at https://nevco.granicus.com/ViewPublisher.php?view_id=3.

For comments to be entered into the administrative record of the meeting, they must be received no later than 8:00 a.m. on the morning of the noticed meeting.
